Align Technology, Inc. ("Align"), who designs, manufacturers and markets the Invisalign® system and iTero® and iOC® intra-oral scanners and OrthoCAD services, is committed to protecting your personal information. The following discloses how we use and share the information we gather on our websites and our partners' sites.

In general, you can visit our websites without telling us who you are or revealing any personal information about yourself. There are times, however, when we may seek information from you, about yourself or someone you know, such as name, email address and/or home address. WHAT DO WE DO WITH THE INFORMATION WE COLLECT?

The information gathered from your use of our websites or provided by you may be used:

- To provide you with information about products, services, news and events.

We partner with other businesses to assist us in our marketing, communications, and sales efforts, and may share information about you for these purposes. These partners are not allowed to use your information for any purpose other than doing business with Align.

In addition, information about our users, including personal information, may be disclosed as part of any merger, acquisition, debt financing, sale of company assets, or similar transaction, as well as in the event of insolvency, bankruptcy or receivership in which personal information could be transferred to third parties as one of our business assets.

COOKIES AND ADVERTISING

Our websites use cookies in order to improve your user experience by enabling that website to 'remember' you, either for the duration of your visit (using a 'session cookie') or for repeat visits (using a 'persistent cookie'). Cookies also help us know how our websites or marketing efforts are working, but these cookies generally do not collect any personal information about you.
